

**REGULAR MEETING
CITY COUNCIL, YORK, NEBRASKA
JUNE 2, 2011**

A meeting of the Mayor and City Council of the City of York, Nebraska, was convened in open and public session at 7:00 o'clock p.m. in the Council Chambers.
