2. The Renter shall pay for any damage or breakage to the building or property there-in that occurs as a result of negligence or misuse of said premises by the Renter.

3. The Renter shall leave the premises in a clean and orderly condition (garbage and other debris picked up and in receptacles) or the City reserves the right to withhold refund of deposits.
4. Rentals that have obtained permission to consume alcohol must cease consumption at 12:00 midnight.
5. All rentals must vacate the premises no later than 2:00 a.m.
6. The City reserves the right to rent all available facilities during any given rental or event.
7. The Renter shall hold the City of York harmless from all liability for injury or death, or loss of or damage to, any person or property that occurs during, or as a result of, the use of facilities by the Renter, and shall indemnify the City for all expenses it may incur as a result of claim or demand by anyone growing out of the use of said facility by the Renter.
8. The City reserves the right to withhold refund of deposits and to establish a larger deposit based on the type of event.
